Thank you for your enquiry over the concerns the parish have over traffic safety around the nursery when parents are attempting to cross Main Road near the bend. In regard to parents crossing to get to the nursery , with the main entrance being off Mycock Lane is this not the favoured drop off and pick up point, as it offers a footway and a turning area if required at the village hall (presuming the gates are open), and reduces any risk of crossing by a bend where it can be difficult to judge any on-coming traffic.

In regard to what can be achieved , when looking at implementing a schemes, such as requests for lower 30mph speed limits which we noted were within the recent parish minutes , we would have to follow set criteria, that guides us to locations that have the greater benefit to the wider community's needs, and would have to show safety benefits gained by reduced levels of accidents, or in areas that create improved linkages for the whole community, especially mobility users for quality of life advantages.

Within a speed limit review of Flagg, we followed guidance set out by the Department for Transport (DfT), and the Derby and Derbyshire Road Safety Partnership Approval of Speed Management Protocol, these both considered local community concerns raised in view of any impact to the quality of life high end speeds cause. The DfT guidance over setting of local speed limits, determines what setup has to be in place for a 30mph speed limit;

The criteria specified above, provides transparency in our decision making processes, and a facility that provides a consistent appraisal method for requests when reviewing speed limits. Core to the process are speed limits that are evidence-led, be self-compliant, and seek to reinforce people's assessment of what is a safe speed to travel.

We have had time to look at the past 5 years of reported injury collision records, none of which have been reported by the nursery , which is a good indication that motorists are aware of the prevailing conditions and drive accordingly.

On a safety note, in addition to their being no evidence of injury accidents, if any on-street parking on Main Road occurs, it can have the beneficial safety effect of moderating and slowing traffic speeds to levels which are more acceptable than if no such parking was taking place.

Officers views currently are that due to the topography and traffic characteristics of the road, it

doesn't encourage undue speeds, as motorists many of which are local residents, reduce their speeds when the road layout presents hazards, such as bends, narrow widths, parked cars, sharing the road with pedestrians, cyclists and weather conditions, however we do appreciate that at times some motorists may travel inappropriately that is causing unnecessary safety concerns around the nursery.

As well as set criteria for any introduction of speed limits , it is not a simple case of relocating existing signs with minimal cost attached, as to introduce a new or relocating of an existing 30mph speed limit for it to be legally enforceable then it requires such infrastructure as a series of street lighting, the speed limit to be publically advertised via a traffic regulation order (TRO), have mean speed readings of 34mph or lower, and a safe and effective location for signs to be positioned.

We are governed by the Department for Transport (DfT) guidance over setting of local speed limits that determines what setup has to be in place for a 30mph speed limit; The cost therefore of bringing in a 30mph speed limit on Main Road and Mycock Lane Flagg, it would attract the accompanying costs of a TRO being in excess of £5,000, new street lighting and ducting, relocating and siting of signs, all of which would incur a significant cost that we simply would not be able to justify on the criteria we use to rank schemes for traffic safety measures.

It is appreciated that at times some motorists may travel inappropriately and that this can cause safety concerns, however, this is the case on most roads, and it is this type of driver that would pay little attention to a speed limit sign.

I am sorry that I cannot offer a more positive response on this occasion, but trust that the above helps to explain the Council's position regarding your request.

We thank you for bringing this issue to our attention, and whilst we appreciate that you may be disappointed with this response, we trust that the above information provides a suitable explanation regarding the Council's position in regard to your enquiry.
